Q: What does my gift fund?

A: Neighborhood Funds, Staff Enrichment & Wellness, or the Greg V. Hanson Scholarship Fund. Simply check which program you would like your gift to fund. If nothing is checked we will split between the programs.

Q: How are "Partners in Caring" gifts used?

A: Gifts to Neighborhood Funds: Contributions to your neighborhood if identified on pledge form. Examples of 2023-2024 investments:

Furnishings Appliances/Electronics Neighborhood Décor Holiday Decorations Personal Effects Personal Hygiene Items Clothing Parties/Snacks/Meals Special Events

Gifts to <u>Staff Enrichment & Wellness</u>: Used for Wellness Program, workshops, guest speakers, special programs and special employee rooms.

Gifts to <u>Greg V. Hanson Scholarship Fund</u>: Used to give an employee the opportunity to become a nurse.

Q: How long will this payroll deduction continue?

A: The payroll deduction that you choose will continue until you request in writing to Human Resources (HR) that it be discontinued.

Q: What if I want to change this payroll deduction?

A: If you would like to change the amount you will need to send a request in writing to HR or the Foundation.

Q: Can I make a one-time cash gift?

A: Yes, simply attach your gift to this card and return to HR or the Foundation office.
