2 024. Another year is into the books for our organization which has proudly and respectfully served this community for 100 years.

I have always felt close to and as though I have a connection to Valley. My first paid job was that of a nurse aide 55 years ago on 1C at Valley Memorial Home at 1023 Almonte Avenue. This job was only for one summer, but it was a wonderful experience. In 1977, my family made our home at a location less than two blocks from Valley Memorial Home. I remember the neighbors telling us if there was ever a fire, we should show up to help the residents.

As the years went by, Valley Memorial Home on Almonte Avenue was a large part of what made our neighborhood what it was. PRESIDENT/CEO REPORT





appy 100th Birthday to Valley Senior Living! On October 15, 1924, we opened our first nursing home. The Grand Forks Home of the Aged was created for the purpose of building and operating a Lutheran Christian home for aged people.

As we look back on life in our community 100 years ago, local churches and their pastors were the central critical social infrastructure serving the needs of those who could not care for themselves. The level of church involvement has decreased over the years with the addition of governmental social programs, but we are proud that Valley continues to be governed by 24 local churches to help us continue with our mission of providing compassionate Christian care. It is incredibly unique to be an organization that has operated exclusively in Grand Forks for the last 100 years as a Lutheran church-governed non-profit corporation!

Our 100th year represents the most "normal" year we have had since 2020. We have been able to recruit a talented, qualified workforce consistently for the last two years, but we continue to have issues with staff retention. While we compare favorably to our peers in overall nursing staff retention and much above average in nurse retention, our staff turnover levels continue to be higher than our pre-pandemic levels.

As a staff, we are proud of the quality care we provide. All four of our care communities received quality awards this year from the American Health Care Association. Valley Senior Living on Columbia, Woodside Village, and Tufte Manor are three of the seven statewide Silver award winners, and Wheatland Terrace received the Bronze award which is held by only five other assisted livings throughout the state. Both of our nursing homes were CMS overall five-star facilities throughout the fiscal year.

Federal minimum staffing standards for nursing facilities were issued by CMS last year. These standards represent insurmountable challenges for many facilities across the country, but they will only have minimal impact to us at Valley Senior Living. The North Dakota Legislature is the reason that most of us already meet the overall staffing requirements, but the 24/7 RN requirement will be extremely hard to meet in small rural facilities.

Thank you to the Executive Committee and the entire leadership team for your dedication to the residents of Valley Senior Living. We have been working together to update our strategic plan this year. One of the largest challenges is to address aging facilities such as Valley on Columbia and Tufte Manor. That planning put us in a position to recently acquire six acres of land next to Sertoma Park just west of Altru Hospital. We are negotiating with Altru to secure an additional 15.5 acres to be the future location of Valley Senior Living. What a unique opportunity to secure a large piece of undeveloped land in a residential setting with proximity to a brand new hospital!

As we celebrate our 100th birthday this fall, I am excited for the years to come!

FINANCIAL OVERVIEW

2023-2024 FISCAL YEAR HIGHLIGHTS

The organization remains financially stable with net assets of \$29.9 million and \$14.9 million in operating cash and CDs, \$2.5 million in funded depreciation and designated reserves, and funds held by bond trustee of \$5.6 million as of June 30, 2024. Operating cash and funded depreciation equate to approximately 117 days cash on hand and 154 days when restricted bond reserves are included. For the fiscal year ending June 30, 2024, the organization experienced an increase in net assets of \$4.3 million which equates to a 7.1% margin for the year. This margin includes accrued revenue of \$1.2 million for the Employee Retention Credit (ERC) explained below and \$658,128 in ND Nursing Facility Incentive Program Payments (NFIP). The margin excluding ERC is 5.2%.

CENSUS AND OCCUPANCY

Consolidated occupancy for the year was 96% compared to 95% consolidated occupancy the prior year. See the following chart for each community's occupancy rates.

STAFFING

Total salary and benefit expenses increased 6% compared to 9% the prior year. We are experiencing fewer open positions with shifts being more consistently filled. Overtime and incentive pay to fill shifts remains notably low for the second year in a row. It remains a high priority of Valley Senior Living to continue to recruit and retain quality staff.

ND Nursing Facility Incentive Payments

North Dakota Health and Human Services established a quality incentive payment program from nursing homes and issued the program's first payments in June of 2024. Facilities are awarded points for performance in various categories. Woodside Village was a Tier 1 facility and received \$382,647 and Valley Senior Living on Columbia qualified for Tier 2 for \$275,481. We anticipate both nursing homes receiving NFIP payments again next June.

EMPLOYEE RETENTION CREDIT

Last year the organization filed for \$11.4 million in ERC credits. The IRS has been paying interest in ERC paid claims and this fiscal year another \$1.2 million of interest was recorded. These funds have not yet been received. The anticipated \$12.6 million in ERC is reflected as a receivable on the Balance Sheet.


OUTLOOK FOR 2024-2025

The 2024-2025 budget is projecting a profit margin of 2.7% and a relatively stable cash position. The budget assumes consolidated occupancy at 96%, a 4.2% increase in revenues, and a 7.1 % increase in expenses.


In July 2024, Valley Homes and Services purchased 6 acres of land for \$1.84 million for future development.





During a pastoral conference at the Mekinock parsonage led by Rev. O. T. Ness of Ness Lutheran Church, the pastors promised the Bethesda women support in building an Old People's Home in Grand Forks. Later that year the Home for the Aged constitution was formed and incorporated.



1924



October 15: The Grand Forks Home of the Aged opened at 1023 Almonte Avenue to care for 40 residents. This property on Almonte Avenue was purchased for \$3,000 in 1919 and the building cost an additional \$30,000 to construct.



A second unit was added at the original location at 1023 Almonte Avenue to increase the size by 32 rooms and cost an additional \$35,000 to build.

1959

The Old People's Home name changed to Valley Memorial Home.

1934

51 residents were living at the Grand Forks Home for the Aged.

51 Are Residing At Grand Forks Home for Aged


Fifty-four persons were registered at the Grand Forks Home for the Aged in February, and 51 were residents at the end of the month, according to Rev. O. T. Ness, manager. Five of the residents were of descent other than Scandinavian

Among activities in February were services February 4 and 18 conducted by the Lutheran Bible school students; meetings February 11, in charge of the Goose River Inner Mission society; meetings of Bethesda No. 3 with Mrs. Ole Larson and Mrs. O. Ostad as hostesses and of Bethesda No. 1 with Mrs. O. T. Ness. Rev. Ludvig Pederson conducted services February 19.

Donations in February included a memorial fund from Buxton friends and proceeds from the Bethesda societies, amounting to \$38.

Mrs. Ole Torbinson entered the home February 2.... Tom Bonde, 304 North Fifth street, stayed at the home for 10 days while convalescing from an illness.... Mrs. C. Paulson is visiting at Northwood.... Mrs. Leonard Ulrich of Big Stone City, S. D., visited her mother, Mrs. Caroline Bottolfson, and Mr. and Mrs. Edwin Bottolfson

were here from Garske, N. D. . . . Mr. and Mrs. Orlando Lebacken and Mr. and Mrs. Olaf Lebacken of Reynolds called on their aunt, Mrs. Marie Lebacken.



A third expansion of the original location added the "Nursing Wing" and capacity to care for 58 more residents.

Valley Memorial Homes name changed to Valley Senior Living to include locations at Valley Senior Living on Columbia, Valley Senior Living on 42nd, and Valley Senior Living on Cherry.

The Bethesda Society concluded their active service to Valley Senior Living in the fall of 2019 after 105 years of supporting the organization in numerous ways.


